# Proceedings of Regular Board Meeting

June 10, 2008

The meeting was called to order by Village President, Mark Bade at 6pm. Present were Trustees; Dorshorst, Haupt, Rybicki, and Ziebell. Absent; none. The meeting was opened with the Pledge of Allegiance.

Haupt moved and Ziebell seconded that the minutes of the preceding meeting be accepted as typed and distributed. Motion carried.

The program transporting the children to the YMCA's swimming will not be running a bus this year because of not enough participation in the program. Vans will be used instead.

Trustee Rybicki has purchased a leaf vacuum for \$2,200.00 and it is stored up at the ag building.

Trustee Haupt obtained a quote of \$825.00 from Fahrner Asphalt to repair the cracks in the tennis courts. Dorshorst moved to accept the bid. Rybicki seconded. Motion carried.

The weight limit signs on Meadowview Lane have been repaired.

Helen Zubella came before the Board asking what St. Philip's Parish would be billed for the school building per quarter for sewer service now that the school is closed. This item will be considered next month.

Ziebell moved that the following licenses be granted:

President Bade stated that he would like to reappoint Jim Brehm and Scott Rybicki to another 3 year term on the Zoning Board of Appeals. Ziebell moved that the appointments be accepted. Rybicki seconded. Motion carried.

Village officials have been invited to a program at the Valaire Jazazewski residence on June 25<sup>th</sup> in recognition of her property's improvement under a government program.

The sewer report for last month was good.

Trustee Haupt reported that the announcing booth at the park has been used by the Little League and there were no problems. The League has asked about using the field's lights but were given no answer. It was decided that they would have to pay by the hour if they used them.

Rybicki moved that Haupt be allowed to spend up to \$50.00 for flowers for the welcome signs. Dorshorst seconded. Motion carried.

Ziebell moved and Rybicki seconded that the Park Committee minutes of their May 22<sup>nd</sup> meeting be approved. Motion carried.

A statement from the Stanczyk's outlining their agreement to install a culvert if any problems with standing water occur because of their not putting one in at thier new residence. This was signed by them and will be kept on file.

The listed bills were presented and approved for payment.

On motion and vote the meeting was adjourned.
